Dear Fellow Members,

Our finances remain steady with the help of your generous donations and our Certificate of Deposit investments.

The attached summary of the last three months shows Revenues of about \$18,500, Expenses of about \$31,400 and a Net Operating Loss of about \$12,900. That deficit is a little over \$2,000 less than last quarter's deficit.

Our investments continue to make steady gains with dividends yielding over \$500 in monthly revenue. The bi-annual collection of interest from our 4 remaining CDs came to about \$1200 in July.

We have yet to receive the donation from the disbanding Clinton, MD, church, though we have had correspondence with them that it is still moving forward.

Even after our \$30,000 draw from the Fidelity Money Market account we have Assets of over \$348,000.

The church continues to run at a deficit of about \$4,000-\$5,000 per month. At that rate, I'd expect us to make another draw from the Fidelity account in early November.

A few more of our members are taking advantage of sending their donations electronically through the Zelle service. Many banks offer Zelle as part of their online banking. If you would like to use this service, you would create a new "Recipient" and use the Treasurer's email address as the account, csfairfax.treasurer@gmail.com. You can then send money without writing a check.
